ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price

- The Offer Price has been determined at HK\$1.38 per Offer Share (excluding brokerage fee of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

Net proceeds from the Global Offering

- Based on the Offer Price of HK\$1.38 per Offer Share, the net proceeds from the Global Offering to be received by the Company, after deduction of the underwriting commission and other estimated expenses payable by the Company in connection with the Global Offering and assuming no exercise of the Over-allotment Option, are estimated to be approximately HK\$81.2 million. The Company intends to apply such net proceeds in accordance with the purposes as set out in the section headed “Net proceeds from the Global Offering” in this announcement.

Applications and indications of interest received under the Hong Kong Public Offering

- The Offer Shares offered under the Hong Kong Public Offering were moderately over-subscribed. A total of 8,367 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms, through giving **electronic application instructions** to HKSCC via CCASS and through the **HK eIPO White Form** Service Provider service for a total of 180,340,000 Hong Kong Offer Shares, representing approximately 20.4 times of the total number of 8,840,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.
- Due to the over-subscription in the Hong Kong Public Offering, the reallocation procedure as described in the paragraph headed “Readjustment of Offer Share between the Hong Kong Public Offering and the International Offering” under the section headed “Structure and conditions of the Global Offering” of the Prospectus have been applied. As the number of the Offer Shares validly applied for in the Hong Kong Public Offering represents 15 times or more but less than 50 times of the number of Hong Kong Offer Shares initially available under the Hong Kong Public Offering, 17,680,000 Shares have been reallocated to the Hong Kong Public Offering from the International Offering, so that the total number of Offer Shares under the Hong Kong Public Offering has been increased to 26,520,000 Offer Shares, representing 30% of the total number of Offer Shares available under the Global Offering (before any exercise of the Adjustment Options). The Offer Shares offered in the Hong Kong Public Offering were conditionally allocated on the basis set out in the paragraph headed “Basis of allocation under the Hong Kong Public Offering” below.

International Offering

- The Offer Shares initially offered under the International Offering were slightly over-subscribed, and the over-subscription in the International Offering represents 1.05 times the total number of Offer Shares initially available for subscription under the International Offering. There were a total of 133 placees under the International Offering. The final number of Offer Shares allocated to the placees under the International Offering is 75,140,000 Offer Shares, including an over-allocation of 13,260,000 Shares, representing approximately 85% of the total number of Offer Shares initially available under the Global Offering (assuming neither the Offer Size Adjustment Option nor the Over-allotment Option is not exercised). A total number of 93 placees has been allotted five board lots of Shares or less, representing approximately 69.9% of the total number of placees under the International Offering. These placees have been allotted approximately 1.0% of the Offer Shares under the International Offering (including over-allocated Shares).
- To the best of their knowledge, information and belief, having made all reasonable enquiries, the Directors confirm that no International Offer Shares have been allocated to placees who are (i) Directors or existing shareholders of the Company; or (ii) core connected persons (as such term is defined in the Listing Rules) of the Company; or (iii) the close associates (as such term is defined in the Listing Rules) of (i) and/or (ii), whether in their names or through nominees.
- The International Offering has been conducted in compliance with the Placing Guidelines. The Directors confirm that no Offer Shares placed by or through the Sole Global Coordinator, the Joint Bookrunners, the Joint Lead Managers and the Underwriters under the Global Offering have been placed with any core connected person (as such term is defined in the Listing Rules) of the Company or to any connected clients (as set out in paragraph 5(2) of the Placing Guidelines) or persons as set out in paragraph 5(1) of the Placing Guidelines, whether in their own names or through nominees.
- The Directors confirm that none of the Offer Shares subscribed for by the placees or the public has been financed directly or indirectly by any of the Directors, the chief executive or senior management of the Company, the Controlling Shareholders, the Substantial Shareholders or the existing Shareholders or any of their subsidiaries, and none of the placees nor the public who have subscribed the Offer Shares, is accustomed to taking instructions from any of the Directors, the chief executive or senior management of the Company, the Controlling Shareholders, the Substantial Shareholders or existing Shareholders of any of the subsidiaries of their respective close associates in relation to the acquisition, disposal, voting or other disposition of Shares registered in his/her/its name or otherwise held by him/her/it.

- The Directors further confirm that (i) no placee will, individually, be placed with more than 10% of the enlarged issued share capital of the Company immediately after the Global Offering (before any exercise of the Adjustment Options); (ii) none of the placees will become a substantial shareholder (as defined in the Listing Rules) of the Company immediately after completion of the Global Offering; and (iii) there will be any new substantial shareholder of the Company immediately upon the Global Offering.

Offer Size Adjustment Option and Over-allotment Option

- In connection with the Global Offering, the Company has granted the Offer Size Adjustment Option to the International Underwriters, exercisable by the Sole Global Coordinator (for itself and on behalf of the International Underwriters), at any time from the date of the International Underwriting Agreement to 5:00 p.m. on the business day immediately before the date of the announcement of the results of allocation and the basis of allocation of the Hong Kong Offer Shares, at the sole discretion, to require the Company allot and issue up to an aggregate of 13,260,000 additional Shares, representing 15% of the initial Offer Shares, at the same Offer Price under the International Offering to solely meet excess demand, if any, in the International Offering. As at the date of this announcement, the Sole Global Coordinator has not exercised the Offer Size Adjustment Option and the Offer Size Adjustment Option has accordingly lapsed.
- In connection with the Global Offering, the Company has also granted the Over-allotment Option to the International Underwriters, exercisable by the Sole Global Coordinator (for itself and on behalf of the International Underwriters), at any time from the Listing Date to Friday, 3 April 2020, being the 30th day after the last day for lodging applications under the Hong Kong Public Offering, to require the Company to issue up to an aggregate of 13,260,000 additional Offer Shares, representing 15% of the total number of Offer Shares initially available under the Global Offering, at the Offer Price under the International Offering to cover over-allocations in the International Offering, if any. There has been an over-allocation of 13,260,000 Shares in the International Offering and such over-allocation will be settled using Shares to be borrowed under the Stock Borrowing Agreement between Top Synergy and the Sole Global Coordinator. Such borrowed Shares will be covered by exercising the Over-allotment Option or by making purchases in the secondary market or by a combination of these means. As at the date of this announcement, the Over-allotment Option has not been exercised. In the event the Over-allotment Option is exercised, an announcement will be made on the websites of the Company and the Stock Exchange at www.kidztech.net and www.hkexnews.hk respectively.

The Directors confirm that the three largest public Shareholders do not hold more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules. The Directors also confirm that there will be at least 300 Shareholders at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules.

Commencement of dealings

- Dealings in the Shares on the Stock Exchange are expected to commence at 9:00 a.m. on Wednesday, 18 March 2020. The Shares will be traded in board lots of 2,000 Shares each. The stock code of the Shares is 6918.

In view of the high concentration of shareholding in a small number of Shareholders, Shareholders and prospective investors should be aware that the price of the Shares could move substantially even with a small number of Shares traded, and should exercise extreme caution when dealing in the Shares.

NET PROCEEDS FROM THE GLOBAL OFFERING

Based on the Offer Price of HK\$1.38 per Offer Share, the net proceeds from the Global Offering to be received by the Company, after deduction of the underwriting commission and other estimated expenses payable by the Company in connection with the Global Offering and assuming no exercise of the Over-allotment Option, are estimated to be approximately HK\$81.2 million. The Company intends to apply such net proceeds as follows:

- approximately HK\$57.5 million (representing approximately 70.8% of the net proceeds) will be used to fund the Planned Expansion, including, among others, construction of the New Production Plant and acquisition of more machinery and equipment for manufacturing toy products and product design and development;
- approximately HK\$15.6 million (representing approximately 19.2% of the net proceeds) will be used to maintain and strengthen the Group's relationship with existing customers, in particular overseas customers, expand and diversify the Group's customer base through, among others, expanding the Group's sales and marketing departments in both Hong Kong and the PRC, and acquire or invest in downstream companies; and
- approximately HK\$8.1 million (representing approximately 10.0% of the net proceeds) will be used for general replenishment of working capital and other general corporate purpose.

A total of 8,367 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms, through giving **electronic application instructions** to HKSCC via CCASS and through the **HK eIPO White Form** Service Provider service for a total of 180,340,000 Hong Kong Offer Shares, representing approximately 20.4 times of the total number of 8,840,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.

Out of the 8,367 valid applications for a total of 180,340,000 Hong Kong Offer Shares:

- 8,363 valid applications for a total of 163,920,000 Hong Kong Offer Shares were for the Hong Kong Public Offering with an aggregate subscription amount based on the maximum Offer Price of HK\$1.47 Offer Share (excluding brokerage fee of 1.0%,

SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%) of HK\$5 million or less, representing approximately 37.1 times of the 4,420,000 Hong Kong Offer Shares initially comprised in Pool A; and
